TOOLS REQUIRED

- Socket set to include 3 & 4mm A/F socket & wrench.

FITTING INSTRUCTIONS

- Remove the OEM chainguard by removing the two bolts that secure it to the swingarm.
- Fit the R&G chainguard using the two M5 bolts & washers supplied, as shown above.
